Re: 2025 Annual Body Worn Cameras Report

To whom it may concern:

In 2025, the Hanover Park Police Department had an authorized size of 61 police officers and 34 civilians. Body-worn cameras are worn by all sworn employees who have completed the basic police academy. As of December 31, 2025, cameras were assigned to 58 officers.

The department had two types of body-worn cameras in 2025: front mount Axon Body 3 and helmet mount Axon Flex 2. The department has 68 front-mount body-worn cameras and 12 helmet mount cameras. Of the 68 front mount cameras, 61 cameras are utilized to assign to each officer and seven cameras are spares.

In 2025, we had one technical issue with a body-worn camera. The camera had an issue recording audio, as it recorded the video, but when the video was played back the audio was muffled/unintelligible.

The department's body-worn camera review process requires the immediate supervisor to review several videos each month for each officer under their supervision. The videos are randomly selected by the digital evidence system for supervisor reviews. The results of each video view are documented, and the chain of command are notified by the digital evidence system of any policy violations.

Attached is the additional data which is required to be reported by 50 ILCS 707/20.
