The Fairbury Police Department is made up of seven full time officers. Our department, with the assistance of the ILETSB grant, purchased four in-car camera and four body worn camera systems from Getac. In total our Department utilizes five body worn cameras. Each in-car system and body worn system was installed in the squads in late 2025 to replace our outdated systems. Each body worn camera stays with each squad and updates and downloads via WiFi connection through the in-car system. Each officer signs into and assigns the cameras to themselves at the start of their shift.

In total our Department has four in-car systems, each with their own body worn camera and one spare body worn camera at the PD.

The only technical issue experienced was a delay in video uploading. This was caused by a programming error in the new systems and did not allow enough storage for the body worn camera footage to download. The was remedied by correcting the programming and switching the blackbox video recording to its dedicated storage device inside the in-car video system.

The review process is random, monthly checks of each Officer.
