**Pursuant to 50 ILCS 706/10-25, please find attached the completed Body-Worn Camera Annual Report and accompanying data chart for the Village of Winnebago Police Department.**

This submission is provided in compliance with the annual reporting requirements of the Illinois Law Enforcement Training and Standards Board Body-Worn Camera Grant Program.

For the 2025 calendar year, the following information is provided:

- **Personnel and Equipment:**

The department currently employs seven (7) full-time officers and one (1) part-time officer. Each officer is assigned an individual body-worn camera, with two (2) additional units maintained as spares. At the time of the grant award, the department employed nine (9) officers; however, one full-time position has since been eliminated by the Village. Additionally, the department was awarded and deployed four (4) in-car camera systems.

- **Review Process:**

Body-worn camera footage is reviewed by department command staff as part of routine supervisory oversight and accountability measures.

- **Video Access and Sharing:**

Access to share video footage via secure cloud-based links is restricted to the Chief of Police and the Lieutenant for the purpose of providing evidence to the State's Attorney's Office and Village Attorney. Officers do not have the ability to delete recorded footage.

- **Training and Compliance:**

All sworn personnel have received training on body-worn camera operation, activation, and procedures in accordance with 50 ILCS 706/10-20 and applicable department policy.

- **Technical Issues Encountered:**


The department experienced the following technical issues during the reporting period:

- Intermittent failures of video footage uploading to the cloud storage system
- Expansion and failure of body-worn camera batteries, rendering certain units inoperable

All identified issues were addressed in coordination with the system manufacturer and the Village's information technology staff. Appropriate corrective actions were taken to restore and maintain system functionality.

All recordings are retained and stored in accordance with applicable statutory retention requirements and department policy. All statistical and case data provided in the accompanying report have been compiled from official department records management and digital evidence systems.
